**Schools/Research-** no new updates

**Plastic Wrap-** 395 pounds of plastic film were collected for December. 163 pounds were collected from the PW bins.

For 2025, we collected 5,219 pounds, compared to 5,701 pounds in 2024. Not sure if the 500 pounds difference is due to the elimination of the Town Building Collection. Trash accounted for 139 pounds, which is 2.6 % of the total weight collected.

We have collected over 42,000 pounds of film since the program's inception, in 2017.

Modified inside of the Pw bin to better capture loose plastic film. Inserted in 2 Trex collection bins with plastic bag liners.

### **Recycling/Trash Info Card Update-**

Member Petrosky stated that it was in the Totoket Times issue that came out today, and it has been at the town offices for about a week already and is posted on Facebook. Member Jakubowski requested that the committee start reviewing the Recycling card in September and then be able to submit it to the Purchasing Agent in November.

### **Earth Day Early Planning- Discussion**

Member Savastano discussed some preliminary things to start planning for Earth Day.

It is typically done on Opening Day of Little League.

- We would need to email the LL President to get the date of Opening Day and get permission to share the field for the event.
- Also email Park & Rec to ask for permission to share the field.
- Start a list of displays/ charts/ layouts/ give aways.
- Draft an "Invite Letter" to include the date and time to include hobbyist, Town Departments, Eco- friendly businesses/ nonprofits.
- Publicity to advertise in the Totoket times/ Banners and on social media.
- **4 weeks before the event:** send out the invites mail, email and personal visit. Work on the displays.
- **2 weeks before the event:** follow on the invitations that were sent.
- **1 week before the event:** 2 banners on each side of town and on the Town Hall green.
- **Tuesday or Wednesday before the event:** get 100 Sunflower seeds to give away.

Member Savastano sent some requests to ADWP Celentano regarding Earth Day- he spoke with Brian Augur yesterday & he is willing to loan one of those hay bale trailers to us so we can get started with setting up the "Recycle Odyssey".

His immediate thought is to ask when we can clean out the garage --because we'll need room to work. His next thought is --he has a short list of some materials to get started & was wondering if there was anything available/leftover from some other jobs that we could use.

There were more comments regarding having the Trash picker for the E-Waste Events as he is funded with our Nip funds. Also possibly having the trash picker to pick up mattresses.

**Plastic Recycling Updates**

**Kate Bailey – Chief Policy Officer - Association of Plastic Recyclers (APR)**

**Economic Problems**

- Low price/excess of new virgin plastic
- Brands are backing off sustainability measures and using less recyclables.
- Influx of imported recycled plastic from Asia is competing with our recycled plastics.
- If recycled plastics are more expensive than virgin plastic, more goes to landfills.

**Study from Berkley**

- Best solution - require more recycled content in products and packaging.

**Benefits**

- Reduces GHG's emissions.
- Climate Goals
- Saves Energy

**Study from Oregon**

- Every time a product uses recycled content (plastic in plastic) or (paper in paper) it always generates an environmental benefit.

**Circular Recycling**

- PET bottles are now capable of being recycled into new bottles for water and soda. A plastic bottle can be recycled about 7 or 8 times. There is a step in the process toward the end called solid state processing (SSP), that restores some of the quality of that recycled PET back to almost its original form. There are other opportunities for looking at various kinds of products to recycle more than once. It really depends on what the market needs are. Currently market for carpet is not doing so well so instead of recycling bottles

into carpet, bottles are being recycled back into bottles. The market drives what plastics are recycled back into.

- Bipartisan, Federal legislation being introduced is the Circle Act – 30% tax credit for investments in recycling infrastructure. New carts on street, new equipment at MERFS, end market investments. Local governments can receive reimbursements too.

### **Durable Items**

- Difficult to recycle durable items like benches and pipes since they have a longer lifespan – they could be recycled but we just do not have the infrastructure to collect and recycle. The take-away – we need stronger collection services for durable goods.
- To use recycled plastics for food takes more energy and water since food grade plastic materials must be high quality vs. recycling plastics for non-food goods.

### **Collection Problem**

- 3 out of 10 plastic bottles are collected. We have the technology and ability to recycle but greater need is the collection process.

### **Black Plastic**

- Not accepted in CT. Although some facilities can handle, not all can, so abide by the facilities with least technology to make it simpler for recycling in CT.
- Companies trying to find new way to create black plastic instead of using carbon black pigment.

### **Vape Waste**

#### **Jennifer Heaton-Jones Executive Director of HRRA**

- There is no end-of-life management for vapes.
- Complex – no one wants to take them.
- Come in all different shapes to attract young users (sippy cup vapes, hoodies with vapes, video games on vape device)
- Contain liquid batteries and liquid chemicals (nicotine or cannabis).
- Not considered e-waste as they have too many parts
- There is no suggested disposal method in CT.
- Extremely expensive to collect and dispose of.
- Can not recycle and should not be thrown in the garbage. There is no best solution for disposal.
- Recommend towns speaking with HHW (Household Hazardous Waste) vendor.
- Discussed concern with public health messages that state, “Vapes are Trash.” For your health yes but should not be disposed of in the trash.

#### **Jesse Schofield (CT Tire Stewardship Program)**

- Approved 9/22/25

- Launch 3/21/2026
- 2.8 – 3.3 million tires enter CT every year, replacing existing tires
- Improper disposal is common – illegal dumping, fire risks, mosquitoes in pooled tire water, costly clean-ups.
- Same tires can be used in profitable markets – retreaded, become roads, tire-derived aggregate, mats, garbage cans, flooring tiles, automotive parts, and more.
- CT passed the first Extended Producer Responsibility (EPR) Law for tires in 2023.
- Manufacturers are required to take responsibility for products at end-of-life.
- Paid by manufacturers (producers) not customers.
- CT will establish free, statewide drop-off network in partnership with covered entities and coordinate tire pickups.
- Supply signage and education materials and communication tools.
- Tires in toys, bicycles, mobility devices, and commercial aircrafts not included.
- Included – passenger car tires, commercial trucks, motorcycles, heavy-duty trucks, buses, golf carts, ATV, construction vehicles, mining, trailers, non-commercial aircraft tires.
- Tires can be collected at transfer stations, recycling centers, retailers, auto shops, and fleet facilities.
- CTS will manage all collection and transportation costs and provide suitable storage containers when necessary.
- Benefits – free and convenient disposal, service for residents, reduces municipal costs for tire collection, hauling, and disposal, improve recycling outcomes, reduce public health and environmental risks from improperly handled tires.
- When should we no longer collect ten dollars for tires? Firm date is March 21st 2026.
- How tires are collected will need to be agreed upon with town and contract signed.

**Ryan Carboni – Environmental Analyst, CEQ (Council Environmental Quality)**

- Public ACT 21 – 58, Section 10
- 5 cent surcharges on alcohol bottles (50 ml or less)
- Given back to municipality.
- Wholesale collect and give back to municipality of sale every April and October
- Cover reduction of solid waste (hiring a recycling coordinator, recycling equipment) or impact of litter (personnel costs to remove, street sweepers, vacuums, brooms)
- Annual review of the program
- 159 municipalities are participating
- Survey data from July 1 2024 – June 30<sup>th</sup> 2025
- 91 responses.
- 2,084,080.00 of NIPS funds were spent for the reporting period. Average for 66 municipalities was \$3,177.00. Most common was use was for equipment and support for personnel. Storm drain filters were the least.
- Some municipalities carry funds over to next year. Some towns do not receive any funds as they do not sell any nips. Amount of money varies from each town. Can carry funds over to purchase larger items (like a street sweeper).
- Those surveyed to date felt program was very effective or rated it as effective.
- NIPS not accepted at recycling centers, so should be thrown in trash

**Chris Leson (CT DEEP)**

- 2024 – bottle bill - 10 cents redemption
- 2025 – increase in redemption of bottles – 2025 approximately 85% redeemed from 50 – 70% in 2024. Big jump in redemption rate at 10 cents.
- There is cross-border redemption happening (truck loads coming from New York)
- For the last 12 months **98, 611, 969 million containers** sold and total fees paid out was **4,930,598 million**
- We lead the nation as most mini containers sold. “The Mini State”
- If search “Bottle Bill Stakeholder Process” can see a summary of payments to towns in CT

**Sherrill Baldwin (CT DEEP) School Recycling Environmental Analyst III**

- Over 1839 emails sent to Principals and Assistant Principals
- Recycling is Mandatory in CT schools
- New law PA 24-45 Organic recycling about recycling food scraps – only about 20 schools meet this new law and will be required to recycle organics. Other schools in state could do this voluntarily. Total number of schools in CT is 1093.
- Law states if school produces 26 tons or more of organic waste and are within 20 miles of a facility that processes that material, they must recycle organic waste
- E-mail to go out to schools this year to complete a survey to see what they are doing
- DEEP staff will conduct site visits to a few schools this year
- Updated website with toolkit for schools
- Two schools attached or are on same property may trigger law.
