### **Temporary Permit**

- Once the process has been completed, you will receive a letter from the North Branford Police Department indicating your TEMPORARY PERMIT is ready for pick up.
- Prior to picking up the Temporary Permit, please make a \$70.00 check (or cash) payable to: **The Town of North Branford**
- Once a Temporary Permit is obtained through the town, the applicant has 60 days to apply for the State Permit. If this is not done in the that time period, the applicant will have to start the entire process over again beginning at the town level. This includes paying all applicable fees.
